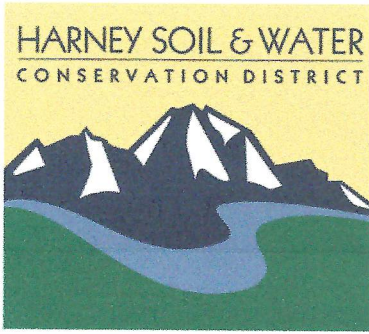


# Juniper Treatment Project Open for Bid Shelly



The Harney Soil and Water Conservation District is accepting bids on a juniper treatment project located on Buchanan, Oregon. The SWCD proposes 466 acres of juniper cut. Of those acres, there are approximately 426 of phase 1 juniper to be cut, lopped and scattered and 40 acres of phase 2 juniper to be cut, bucked, and piled and/or hand pile limbs when slope precludes machine access. There is a mandatory bid tour **beginning at 8:30 am on Thursday April 16, 2024** at the SWCD office. **A representative from your company must be present in person on bid tour.** Bids are due either by hand delivery or by email no later than **May 21, 2024 at 4:00 pm**. All work must be completed by **June 1, 2025**.
